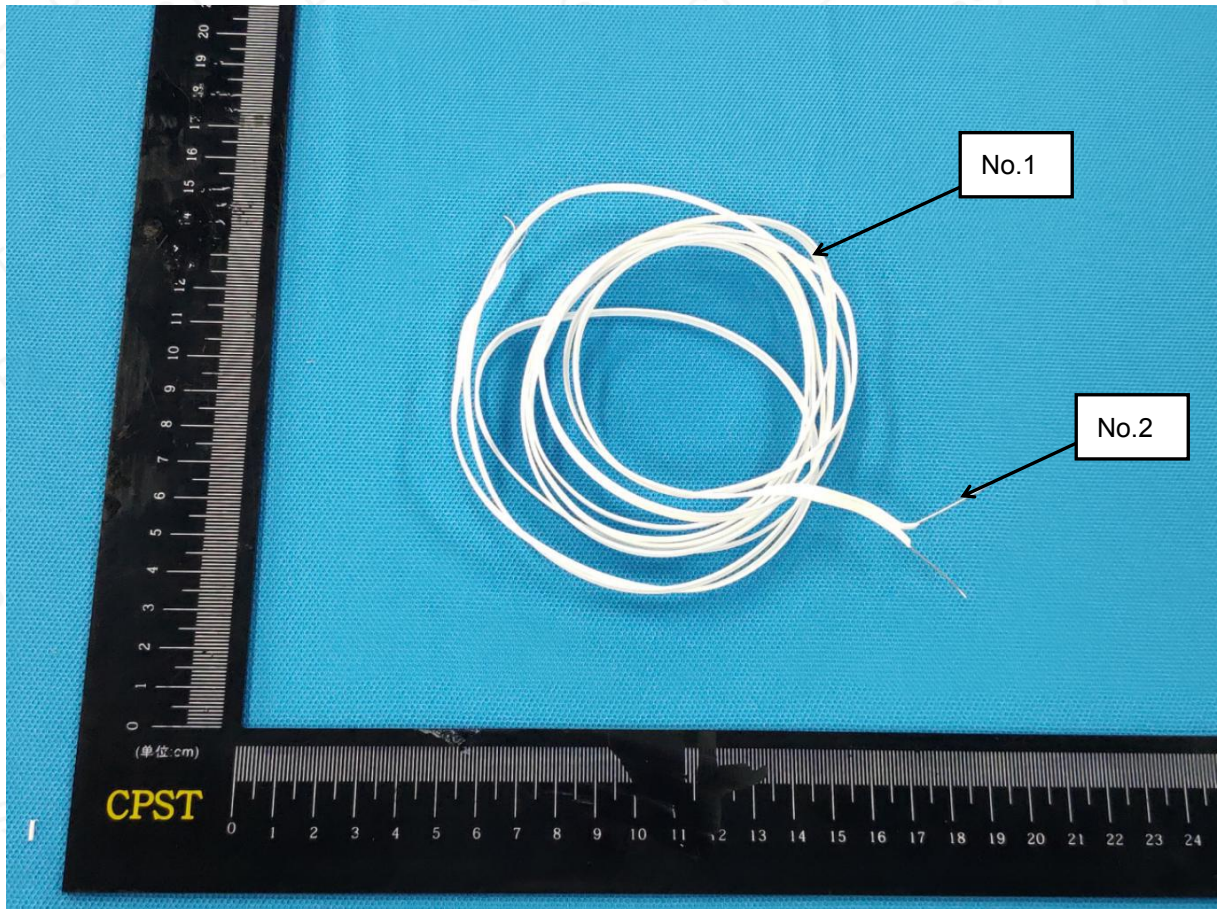

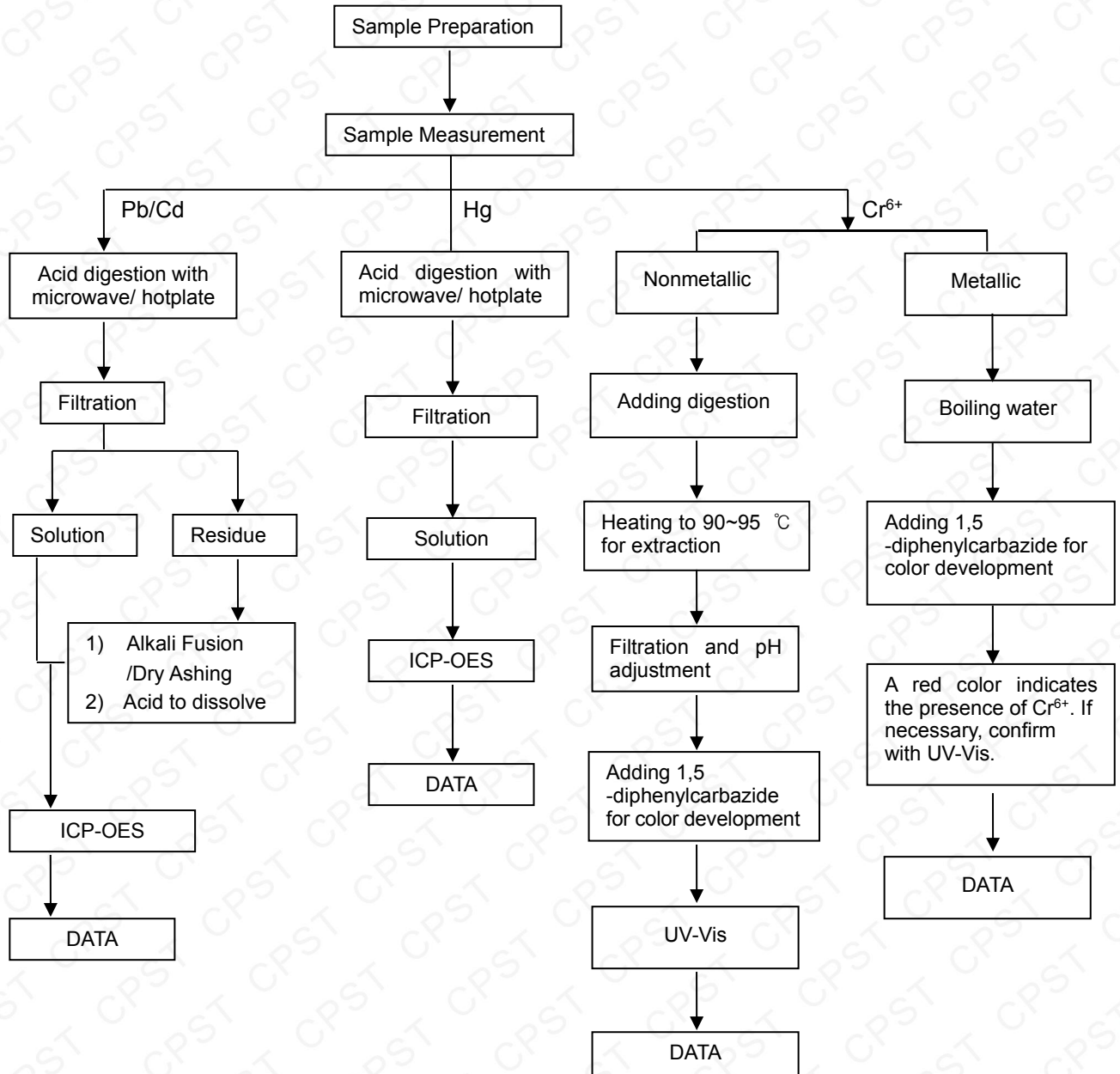

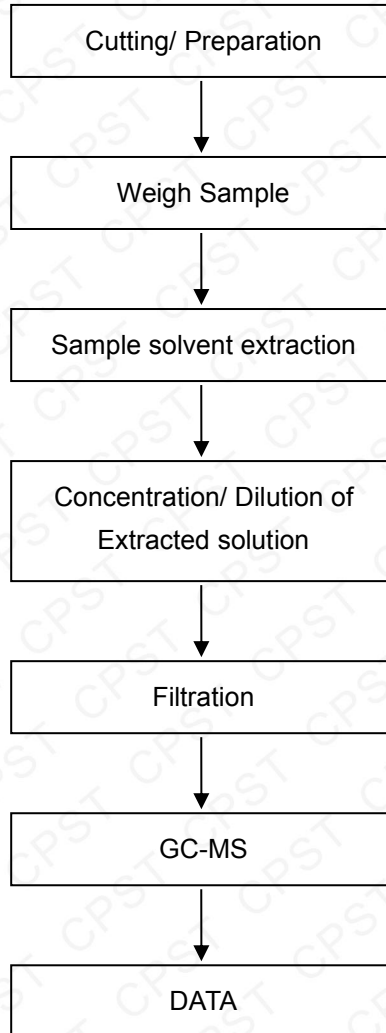
Pb/Cd/Hg/Cr⁶⁺ Testing Flow Chart

(Cr⁶⁺ test method excluded)



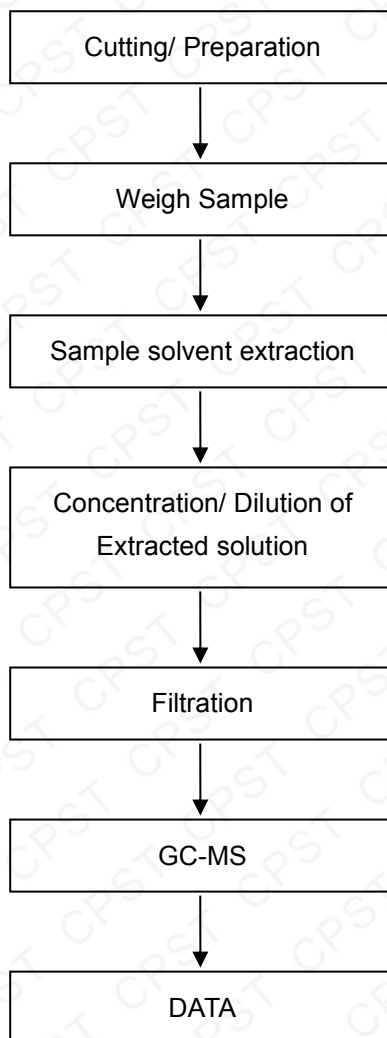
